## Learner Information

Employees use a variety of soft skills in the workplace including problem solving to manage situations. One step in problem solving is understanding the difference between fact vs opinion.

#### The Difference Between Fact and Opinion

In the workplace, a "fact" is a statement that can be verified as true through data and observation, while an "opinion" is a statement of personal belief or judgment that is based more on individual interpretation and feelings than on concrete evidence. As such opinions can vary from person to person. Essentially, a fact is something you can prove, while an opinion is what someone thinks about something.

Question to Ask	Fact	Opinion
Does it have evidence? Can it be proven to be 100% true or false?	>	×
Does it include numbers, dates or data?	>	×
Does it use impartial language?	<b>&gt;</b>	×
Can it be verified through data reports, research documents, supervisor emails, or direct observation?	~	×
Does it avoid use of words and phrases such as; always, never, best, worst, I believe, I think, I feel, I am convinced, etc.?	~	×
